This is in reference to your abbreviated new drug application (ANDA) dated October 2, 2003, submitted pursuant to Section 505(j) of the Federal Food, Drug, and Cosmetic Act (the Act), for Levocarnitine Tablets USP, 330 mg.

Reference is also made to your amendments dated February 13, May 28, July 13, and September 1, 2004.

We have completed the review of this abbreviated application and have concluded that the drug is safe and effective for use as recommended in the submitted labeling. Accordingly, the application is approved. The Division of Bioequivalence has determined your Levocarnitine Tablets USP, 330 mg, to be bioequivalent and, therefore, therapeutically equivalent to the listed drug (Carnitor[®] Tablets, 330 mg, of Sigma Tau Pharmaceuticals, Inc.). Your dissolution testing should be incorporated into the stability and quality control program using the same method proposed in your application.

Under Section 506A of the Act, certain changes in the conditions described in this abbreviated application require an approved supplemental application before the change may be made.


Post-marketing reporting requirements for this abbreviated application are set forth in 21 CFR 314.80-81 and 314.98. The Office of Generic Drugs should be advised of any change in the marketing status of this drug.
