Dear Ms. Dougherty:

Please refer to your supplemental new drug application, dated and received October 1, 2010, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act for Demerol (meperidine hydrocholoride).

This Changes Being Effected supplemental new drug application proposes the following changes: inclusion of safety information in the WARNINGS, PRECAUTIONS, and ADVERSE REACTIONS sections of the package insert.

We have completed our review of this supplemental application, and it is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm. Content of labeling must be identical to the enclosed labeling (text for the package insert), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.
