Dear Dr. Marek:

Please refer to your Supplemental New Drug Application (sNDA) dated and received December 20, 2012, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for REBETOL (ribavirin, USP) 200 mg Capsules and 40 mg/mL Oral Solution.

We acknowledge receipt of your amendments dated February 20, 2013 and May 9, 2013.

These "Prior Approval" supplemental new drug applications provide for revisions to the Dosage and Administration Section of the labeling by removing PegIntron dosing recommendations and modifying the dose reduction table for PegIntron/REBETOL combination therapy and to update the Medication Guide to be consistent with labeling regarding REBETOL use and pregnancy.

We have completed our review of these supplemental applications, as amended. The applications are approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at <http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>. Content of labeling must be identical to the enclosed labeling (text for the package insert and Medication Guide), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Information on submitting SPL files using eList may be found in the guidance for industry titled "SPL Standard for Content of Labeling Technical Qs and As at <http://www.fda.gov/downloads/DrugsGuidanceComplianceRegulatoryInformation/Guidances/UCM072392.pdf>

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

PROMOTIONAL MATERIALS

You may request advisory comments on proposed introductory advertising and promotional labeling. To do so, submit the following, in triplicate, (1) a cover letter requesting advisory comments, (2) the proposed materials in draft or mock-up form with annotated references, and (3) the package insert(s) to:
