Please refer to your New Drug Application (NDA) dated November 20, 2012, received November 20, 2013, submitted under section 505(b)(2) of the Federal Food, Drug, and Cosmetic Act for Nymalize, (Nimodipine) 60 mg/ml Oral Solution.

We acknowledge receipt of your amendments dated November 30, 2012, February 11, 2013, April 4, 2013, April 30, 2013, May 6, 2013, and May 9, 2013.

The November 20, 2012, submission constituted a complete response to our August 16, 2012, action letter.

This new drug application provides for the use of Nymalize, (Nimodipine) 60 mg/ml Oral Solution for Subarachnoid Hemorrhage.

We have completed our review of this application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed agreed-upon labeling text.

## **CONTENT OF LABELING**

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at <http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>. Content of labeling must be identical to the enclosed labeling (text for the package insert). Information on submitting SPL files using eLIST may be found in the guidance for industry titled "SPL Standard for Content of Labeling Technical Qs and As" at <http://www.fda.gov/downloads/Drugs/GuidanceComplianceRegulatoryInformation/Guidances/UCM072392.pdf>.

The SPL will be accessible via publicly available labeling repositories.

## **CARTON AND IMMEDIATE CONTAINER LABELS**

We acknowledge your April 4, 2013, submission containing final printed carton and container labels.

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients, new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for the claimed indication(s) in pediatric patients unless this requirement is waived, deferred, or inapplicable.

Because the drug product for this indication has orphan drug designation, you are exempt from this requirement.
