Dear Ms. Johnson:

Please refer to your Supplemental New Drug Application (sNDA) originally received July 27, 2011, and resubmitted on December 2, 2013 under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Dutoprol (metoprolol succinate extended release/hydrochlorothiazide) 25 mg/ 12.5 mg; 50 mg / 12.5 mg and 100 mg / 12.5 mg tablets.

We acknowledge receipt of your amendment dated November 7, 2013.

The December 2, 2013, submission constituted a complete response to our November 16, 2012, action letter.

This "Prior Approval" supplemental new drug application provides for revisions to comply with the requirements of 21 CFR 201.56(a) and (d) and 201.57.

### **APPROVAL & LABELING**

We have completed our review of this supplemental application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

# **CONTENT OF LABELING**

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at <a href="http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm">http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm</a>. Content of labeling must be identical to the enclosed labeling (text for the package insert), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

You may request advisory comments on proposed introductory advertising and promotional labeling.
