Intended Use / Indications for Use

The Ceralas D 980 is intended for delivery of laser light to soft tissue in the contact or non-contact mode during surgical procedures, including via endoscopes, introducers, or catheters. The Ceralas D 980 is generally indicated for incision, excision, vaporization, ablation, hemostasis, or coagulation of soft tissue in ear, nose and throat and oral surgery (otolaryngology), dental procedures, arthroscopy, gastroenterology, general surgery, dermatology, plastic surgery, podiatry, urology, gynecology, neurosurgery (peripheral nervous system), pulmonary surgery, and cardiothoracic surgery. This Ceralas D 980 is specifically indicated for hemostasis and coagulation of soft tissue (including cardiac tissue) and laser assisted lipolysis.

Technological Characteristics

The Ceralas D 980 for laser assisted lipolysis has the same technological characteristics as the cleared Ceralas and substantially similar technological characteristics as compared to the Cynosure SmartLipo laser.

Performance Data

No performance data is being submitted.

Substantial Equivalence

The Ceralas D is as safe and effective as Biolitec's cleared Ceralas Diode Laser System (K964497, K993911, K032863, K983058, K991891, K993002), as well as the Cynosure SmartLipo Laser Nd:YAG Laser System (K062321). The Ceralas D has the same intended uses and similar indications, technological characteristics, and principles of operation as its predicate devices. The minor technological differences between the Ceralas D and its predicate devices raise no new issues of safety or effectiveness. Thus, the Ceralas D is substantially equivalent.

We have reviewed your Section 510(k) premarket notification of intent to market the device referenced above and have determined the device is substantially equivalent (for the indications for use stated in the enclosure) to legally marketed predicate devices marketed in interstate commerce prior to May 28, 1976, the enactment date of the Medical Device Amendments, or to devices that have been reclassified in accordance with the provisions of the Federal Food, Drug, and Cosmetic Act (Act) that do not require approval of a premarket approval application (PMA). You may, therefore, market the device, subject to the general controls provisions of the Act. 
