Dear Ms. Nehring,

Please refer to your supplemental new drug application dated November 20, 2001, received November 21, 2001, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act for REBETOL® (ribavirin) capsules for use in combination with the approved biologic product Intron®A (interferon alfa 2b) (REBETRON COMBINATION THERAPY™).

We acknowledge receipt of your submissions dated April 22, 2002, June 26, 2002, and August 12, 2002.

This supplemental new drug application provides for :

1. The revision of the OVERDOSAGE section of the REBETRON COMBINATION THERAPY™ and REBETOL® package inserts. This revision provides for the inclusion of signs, symptoms of acute overdosage and general principles of treatment.
2. The inclusion of a statement in the REBETRON COMBINATION THERAPY™ package insert and medication guide, to clarify the proper use of the multidose pen and to stress the importance of not sharing this device with others.

We have completed the review of this supplemental application, as amended, and have concluded that adequate information has been presented to demonstrate that the drug product is safe and effective for use as recommended in the agreed upon labeling text. Accordingly, the supplemental application is approved effective on the date of this letter.

The final printed labeling (FPL) must be identical to the submitted draft labeling (package insert submitted August 12, 2002, patient package insert submitted August 12, 2002).

Please submit the copies of final printed labeling (FPL) electronically according to the guidance for industry titled *Providing Regulatory Submissions in Electronic Format - NDA* (January 1999). Alternatively, you may submit 20 paper copies of the FPL as soon as it is available but no more than 30 days after it is printed. Please individually mount ten of the copies on heavy-weight paper or similar material. For administrative purposes, this submission should be designated "FPL for approved supplement NDA 20-903/S-023." Approval of this submission by FDA is not required before the labeling is used.

In addition, please submit three copies of the introductory promotional materials that you propose to use for this product. All proposed materials should be submitted in draft or mock-up form, not final print. Please submit one copy to this Division and two copies of both the promotional materials and the package insert directly to:
