Please refer to your supplemental new drug applications dated March 27, 2002, received March 28, 2002, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act for Lupron Depot[®] 7.5 mg, Lupron Depot[®] - 3 Month 22.5 mg and Lupron Depot[®] - 4 Month 30 mg (leuprolide acetate for depot suspension).

We acknowledge receipt of your submissions dated November 27 and December 13, 2002. These supplemental new drug applications provide for the Geriatric labeling and revisions to the package insert.

We have completed the review of these supplemental applications and have concluded that adequate information has been presented to demonstrate that the drug product is safe and effective for use as recommended in the agreed upon labeling text. Accordingly, these supplemental applications are approved effective on the date of this letter.

The final printed labeling (FPL) must be identical to the submitted labeling dated December 13, 2002.

Please submit the FPL electronically according to the guidance for industry titled Providing Regulatory Submissions in Electronic Format – NDA. Alternatively, you may submit 20 paper copies of the FPL as soon as it is available, in no case more than 30 days after it is printed. Please individually mount ten of the copies on heavy-weight paper or similar material. For administrative purposes, this submission should be designated "FPL for approved supplement NDA 19-732/S-023 and NDA 20-517/S-013." Approval of these submissions by FDA is not required before the labeling is used.
