Please refer to your supplemental new drug application dated October 13, 2003, received October 14, 2003, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act for Colgate Total® Toothpaste (0.24% sodium fluoride and 0.30% triclosan).

This Changes Being Effected supplemental new drug application provides for a change in the flavor component from Nordicmint flavor at 1.1% to High Impact Doublemint at 1.6% for Colgate Total® 2 in 1 Toothpaste and Mouthwash Freshness.

We have completed our review of this supplemental application and it is approved effective on the date of this letter.

The final printed labeling (FPL) must be identical to the submitted draft labeling (4.6 oz and 5.8 oz. bottle labels submitted October 13, 2003). Please submit the FPL electronically according to the guidance for industry titled *Providing Regulatory Submissions in Electronic Format - NDA*. Alternatively, you may submit 20 paper copies of the FPL as soon as it is available, in no case more than 30 days after it is printed. Please individually mount ten of the copies on heavy-weight paper or similar material. For administrative purposes, this submission should be designated "FPL for approved supplement NDA 20-231/S-033." Approval of this submission by FDA is not required before the labeling is used.

In addition, we recommend that the statement "Call toll-free" be revised to appear in regular (unbolded) type under the "Questions or comments?" section of the labeling for all product sizes. We remind you to remove the word "NEW" on the principal display panel (PDP) after 180 days of marketing.

If you issue a letter communicating important information about this drug product (i.e., a “Dear Health Care Professional” letter), we request that you submit a copy of the letter to this NDA and a copy to the following address:
