Please refer to your supplemental new drug application dated May 18, 2004, received May 19, 2004, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act for Protonix[®] (pantoprazole) Delayed-Release Tablets.

This supplemental new drug application provides for the reformatting of the **Postmarketing Reports** subsection of the **ADVERSE EVENTS** section of the package insert.

We completed our review of this application. This application is approved, effective on the date of this letter, for use as recommended in the agreed-upon labeling text.

The final printed labeling (FPL) must be identical to the submitted labeling (package insert submitted May 18, 2004).

Please submit the FPL electronically according to the guidance for industry titled Providing Regulatory Submissions in Electronic Format – NDA. Alternatively, you may submit 20 paper copies of the FPL as soon as it is available, in no case more than 30 days after it is printed. Please individually mount 15 of the copies on heavy-weight paper or similar material. For administrative purposes, this submission should be designated "FPL for approved supplement NDA 20-987/S-026." Approval of this submission by FDA is not required before the labeling is used.

In addition, submit three copies of the introductory promotional materials that you propose to use for this product. Submit all proposed materials in draft or mock-up form, not final print. Send one copy to this division and two copies of both the promotional materials and the package insert directly to:
