Dear Ms. Cooke:

Please refer to your supplemental new drug application dated July 14, 2005, received July 15, 2005, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act for Ponstel (Mefenamic Acid Capsules, USP).

This "Changes Being Effected" supplemental new drug application was submitted in response to the Agency's letter dated June 14, 2005, requiring class labeling language for all non-selective non-steroidal anti-inflammatory drugs (NSAIDs), to include a boxed warning to address possible cardiovascular risks as well as known gastrointestinal risks, revised **CONTRAINDICATIONS**, **WARNINGS** and **PRECAUTIONS** sections of the package insert, and a **MedGuide** for NSAIDs.

We have completed our review of this application and it is approved, effective on the date of this letter, for use as recommended in the agreed-upon labeling text.

The final printed labeling (FPL) must be identical, and include the revisions indicated, to the enclosed labeling text for the package insert and the MedGuide. The revisions were agreed upon during a January 4, 2006 teleconference. These revisions are terms of the approval of this application.

Please submit an electronic version of the FPL according to the guidance for industry titled *Providing Regulatory Submissions in Electronic Format - NDA*. Alternatively, you may submit 20 paper copies of the FPL as soon as it is available but no more than 30 days after it is printed. Individually mount 15 of the copies on heavy-weight paper or similar material. For administrative purposes, designate this submission "**FPL for approved supplement NDA 15-034/S-039.**" Approval of this submission by FDA is not required before the labeling is used.

If you issue a letter communicating important information about this drug product (i.e., a “Dear Health Care Professional” letter), we request that you submit a copy of the letter to this NDA and a copy to the following address:
