Dear Madam:

This is in reference to your abbreviated new drug application (ANDA) dated April 30, 2004, submitted pursuant to section 505(j) of the Federal Food, Drug, and Cosmetic Act (the Act), for Ciprofloxacin and Dextrose (5%) Injection USP, 2 mg/mL, packaged in 200 mg/100 mL and 400 mg/200 mL Single-use flexible plastic containers.

Reference is also made to the tentative approval letter issued by this office on September 21, 2005, and to your amendments dated May 3, and November 7, 2007; and January 22, and February 8, 2008.

We have completed the review of this ANDA and have concluded that adequate information has been presented to demonstrate that the drug is safe and effective for use as recommended in the submitted labeling. Accordingly the ANDA is approved, effective on the date of this letter. The Division of Bioequivalence has determined your Ciprofloxacin and Dextrose (5%) Injection USP, 2 mg/mL, packaged in Single-use flexible plastic containers to be bioequivalent and, therefore, therapeutically equivalent to the reference listed drug, Cipro I.V., in Dextrose 5% Injection, 2 mg/mL, (Single-use flexible container) of Bayer Pharmaceuticals Corp.

Under section 506A of the Act, certain changes in the conditions described in this ANDA require an approved supplemental application before the change may be made.

Postmarketing reporting requirements for this ANDA are set forth in 21 CFR 314.80-81 and 314.98. The Office of Generic Drugs should be advised of any change in the marketing status of this drug.

Promotional materials may be submitted to FDA for comment prior to publication or dissemination. Please note that these submissions are voluntary. If you desire comments on proposed launch promotional materials with respect to compliance with applicable regulatory requirements, we recommend you submit, in draft or mock-up form, two copies of both the promotional materials and package insert directly to:
