Dear Madam:

This is in reference to your abbreviated new drug application (ANDA) dated May 10, 2007, submitted pursuant to section 505(j) of the Federal Food, Drug, and Cosmetic Act (the Act), for Zaleplon Capsules, 5 mg and 10 mg.

Reference is also made to your amendments dated October 31, and November 27, 2007; and February 20, February 26, March 25, and April 30, 2008.

We have completed the review of this ANDA and have concluded that adequate information has been presented to demonstrate that the drug is safe and effective for use as recommended in the submitted labeling. Accordingly the ANDA is approved, effective on the date of this letter. The Division of Bioequivalence has determined your Zaleplon Capsules, 5 mg and 10 mg, to be bioequivalent and, therefore, therapeutically equivalent to the reference listed drug, Sonata® Capsules, 5 mg and 10 mg, respectively, of King Pharmaceuticals Research and Development, Inc. Your dissolution testing should be incorporated into the stability and quality control program using the same method proposed in your application.

The listed drug product (RLD) referenced in your application, King's Sonata Capsules, 5 mg and 10 mg, was subject to a period of patent protection. As noted in the agency's publication titled Approved Drug Products with Therapeutic Equivalence Evaluations, the "Orange Book", U.S. Patent No. 4,626,538 (the '538 patent) expired on June 6, 2008.

Your ANDA contains a paragraph III certification to the listed '538 patent under section 505(j)(2)(A)(vii)(III) of the Act. This certification states that Unichem Laboratories Limited will not market Zalepon Capsules, 5 mg and 10 mg, prior to the expiration of this patent. The agency recognizes that the '538 patent has expired, and that it no longer prevents the agency from approving your application.

Under section 506A of the Act, certain changes in the conditions described in this ANDA require an approved supplemental application before the change may be made.

Postmarketing reporting requirements for this ANDA are set forth in 21 CFR 314.80-81 and 314.98. The Office of Generic Drugs should be advised of any change in the marketing status of this drug.

Promotional materials may be submitted to FDA for comment prior to publication or dissemination. Please note that these submissions are voluntary. If you desire comments on proposed launch promotional materials with respect to compliance with applicable regulatory requirements, we recommend you submit, in draft or mock-up form, two copies of both the promotional materials and package insert directly to:
