Please refer to your supplemental new drug application dated November 19, 2008, received November 19, 2008, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act for Children's Advil[®] Cold (100 mg ibuprofen and 15mg/5ml pseudoephedrine HCl) suspension.

We acknowledge receipt of your correspondence dated May 18, 2009.

This supplemental new drug application (NDA) provides for the revised cardiovascular warning statement "When using this product the risk of heart attack or stroke may increase if you use more than directed or for longer than directed" to the Drug Facts label in response to the September 19, 2008 supplemental labeling request letter.

We have completed our review of this supplemental new drug application. It is approved, effective on the date of this letter, for use as recommended in the final printed labeling (FPL) for the Children's Advil[®] Cold suspension 4 oz. carton and immediate container (grape flavor) submitted on November 19, 2008.

We remind you of your agreement, stated in your submission dated May 18, 2009, to revise the statement of identity on the Principal Display Panel on all stock keeping units to appear in bold type and in a size reasonably related to the most prominent printed matter (see 21 CFR 201.61(c)) at the time of next printing.

We note that any labeling submitted in a subsequent supplemental new drug application should incorporate the revision listed above.
