Dear Dr. Kubasak:

Please refer to your Supplemental Biologics License Application (sBLA), dated September 14, 2010, received September 15, 2010, submitted under section 351 of the Public Health Service Act for Enbrel (etanercept).

This Prior Approval labeling supplement to your biologics license application proposes to include information regarding systemic vasculitis to the ADVERSE REACTIONS section of the package insert for Enbrel (etanercept).

We have completed our review of this supplemental application. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit, via the FDA automated drug registration and listing system (eLIST), the content of labeling [21 CFR 601.14(b)] in structured product labeling (SPL) format, as described at <http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>, that is identical to the enclosed labeling (text for the package insert submitted on September 2, 2010), and include the labeling changes proposed in any pending "Changes Being Effected" (CBE) supplements. Information on submitting SPL files using eLIST may be found in the guidance for industry titled "SPL Standard for Content of Labeling Technical Qs and As" at <http://www.fda.gov/downloads/Drugs/GuidanceComplianceRegulatoryInformation/Guidances/UCM072392.pdf>. For administrative purposes, please designate this submission "**Product Correspondence – Final SPL for approved BLA STN 103795/S-5443.**"

Also within 14 days, amend all pending supplemental applications for this BLA, including pending "Changes Being Effected" (CBE) supplements, for which FDA has not yet issued an

action letter, with the content of labeling [21 CFR 601.12(f)] in MS Word format that includes the changes approved in this supplemental application.

The SPL will be accessible via publicly available labeling repositories.
