Please refer to your supplemental New Drug Application (sNDA) dated May 6, 2014, received May 9, 2014, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Locoid[®] (hydrocortisone butyrate) Cream, 0.1%.

We acknowledge receipt of your amendments dated June 19; September 8, and 12; and October 1, 2014.

This "Prior Approval" supplemental new drug application proposes the following changes to the labeling:

- 1. Incorporation of the results of the 2-year dermal rat carcinogenicity study conducted with $Locoid^{@}$ Lotion, 0.1%
- 2. Revision of the NDC number, contact and manufacturer information

APPROVAL & LABELING

Content of labeling must be identical to the enclosed labeling (text for the package insert) submitted on October 20, 2014, with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

CARTON AND IMMEDIATE CONTAINER LABELS

Submit final printed carton and immediate container labels that are identical to the enclosed carton and immediate container labels, submitted on September 12, 2014.

Please submit these labels electronically according to the guidance for industry *Providing* Regulatory Submissions in Electronic Format – Human Pharmaceutical Product Applications and Related Submissions Using the eCTD Specifications (June 2008). Alternatively, you may submit 12 paper copies, with 6 of the copies individually mounted on heavy-weight paper or similar material. For administrative purposes, designate this submission "Final Printed Carton and Container Labels for approved NDA 018514/S-013." Approval of this submission by FDA is not required before the labeling is used.

Marketing the product(s) with FPL that is not identical to the approved labeling text may render the product misbranded and an unapproved new drug.

REQUIRED PEDIATRIC ASSESSMENTS

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients, new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for the claimed indication(s) in pediatric patients unless this requirement is waived, deferred, or inapplicable.
