Dear Dr. Sishta:

Please refer to your Supplemental New Drug Application (sNDA) dated and received February 10, 2014, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Videx (didanosine), powder, 2 mg and 4 mg.

We acknowledge receipt of your amendments dated July 14, 2014 and July 16, 2014.

This Prior Approval supplemental new drug application proposes the following changes:

1. To remove Maximum Strength Mylanta reconstitution information from labeling since it is longer marketed in the United States and to add instructions for constituting with commercially available antacids that are equivalent to Maximum Strength Mylanta.
2. To update labeling based upon the Agency's current labeling guidelines.

We have completed our review of this supplemental application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

**CONTENT OF LABELING**

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at <http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>. Content of labeling must be identical to the enclosed labeling (text for the package insert and Medication Guide), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

You may request advisory comments on proposed introductory advertising and promotional labeling. To do so, submit the following, in triplicate, (1) a cover letter requesting advisory comments, (2) the proposed materials in draft or mock-up form with annotated references, and (3) the package insert(s) to:
