## Dear Madam:

Please refer to your supplemental new drug application dated August 08, 2013, submitted pursuant to 21 CFR 314.70(c) (6) [Supplement – Changes Being Effected] regarding your abbreviated new drug application for Ceftriaxone for Injection USP, 250 mg, 500 mg, 1 g, and 2 g per vial.

This supplement provides for revisions to the CLINICAL PHARMACOLOGY - Microbiology subsection and to the REFERENCES section of the package insert to be in accord with the most recently approved labeling of the innovator drug, Rocephin<sup>®</sup> (ceftriaxone sodium) for Injection, NDA 50585/S-065, approved April 12, 2013.

We have completed the review of your application and it is approved.

We note that if FDA requires a Risk Evaluation & Mitigation Strategy (REMS) for a listed drug, an ANDA citing that listed drug also will be required to have a REMS. See section 505-1(i) of the Act.

In addition, as required under 21 CFR 314.81(b)(3)(i), you must submit your updated final promotional materials, and the package insert(s), at the time of initial dissemination or publication, accompanied by a Form FDA-2253, directly to the above address. We remind you that you must comply with the requirements for an approved abbreviated new drug application described in 21 CFR 314.80-81.

The Generic Drug User Fee Amendments of 2012 (GDUFA) (Public Law 112-144, Title III) established certain provisions with respect to self-identification of facilities and payment of annual facility fees. Your ANDA identifies at least one facility that is subject to the self identification requirement and payment of an annual facility fee. Self-identification must occur by June 1 of each year for the next fiscal year. Facility fees must be paid each year by the date specified in the Federal Register notice announcing facility fee amounts. All finished dosage form (FDFs) or active pharmaceutical ingredient (APIs) manufactured in a facility that has not met its obligations to self-identify or to pay fees when they are due will be deemed misbranded.
