Please refer to your Supplemental New Drug Application (sNDA) dated and received July 17, 2013, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for VICTRELIS<sup>®</sup> (boceprevir), 200 mg capsules.

We acknowledge receipt of your amendments dated October 1, 2013, November 21, 2013, January 10, 2014, January 15, 2014 and January 16, 2014.

This "Prior Approval" supplemental new drug application was submitted to add the calcium channel blockers, amlodipine, diltiazem, nisoldipine and verapamil to the Drug Interaction section and to add alfusozin, doxasozin, silodosin and tamsulosin to the Contraindications section of the Package Insert. In addition, the calcium channel blockers and contraindicated drugs were added to the Medication Guide.

## **APPROVAL & LABELING**

We have completed our review of this supplemental application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

Content of labeling must be identical to the enclosed labeling (text for the package insert, text for the Medication Guide), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.
