Please refer to your New Drug Application (NDA) dated June 7, 2013, received October 18, 2013, submitted pursuant to section 505(b)(2) of the Federal Food, Drug, and Cosmetic Act (FDCA) for paricalcitol injection.

We acknowledge receipt of your amendments dated August 2, 26 and September 27, 2013, July 3, October 10, November 6, 10, 2014.

This new drug application provides for the use of paricalcitol injection for the prevention and treatment of secondary hyperparathyroidism associated with chronic kidney disease Stage 5.

We have completed our review of this application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed agreed-upon labeling text.

#### WAIVER OF HIGHLIGHTS SECTION

We are waiving the requirements of 21 CFR 201.57(d)(8) regarding the length of Highlights of prescribing information. This waiver applies to all future supplements containing revised labeling unless we notify you otherwise.

# **CONTENT OF LABELING**
