Please refer to your Supplemental New Drug Application (sNDA) dated July 01, 2015, received July 02, 2015, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Metronidazole Injection, USP, in PAB Plastic Containers.

This "Prior Approval" supplemental new drug application provides for revisions to the microbiology subsection of the labeling as requested in the Agency's letter of June 1, 2015.

## **APPROVAL & LABELING**

Content of labeling must be identical to the enclosed labeling (text for the package insert), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).
