## SUPPLEMENT APPROVAL

Dear Dr. Balderson:

Please refer to your Supplemental New Drug Application (sNDA) dated October 21, 2014, received October 21, 2014, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for SELZENTRY® (maraviroc), 150 mg and 300 mg tablets.

We acknowledge receipt of your amendments dated March 25, 2015 and April 7, 2015.

This prior approval supplemental new drug application proposes the following changes:

- To update DOSAGE AND ADMINISTRATION; Table 1 and CLINICAL PHARMACOLOGY; Pharmacokinetics; Table 10 with information regarding the use of elvitegravir and ritonavir combination therapy, and to remove telaprevir information because it is no longer marketed nor distributed in the United States.
- To revise the HIV-1/hepatitis C and HIV-1/hepatitis B co-infected information under WARNINGS AND PRECAUTIONS; 5.1 Hepatotoxicity.
- To update the "Tell your healthcare provider about all the medicines you take", section of the MEDICATION GUIDE with elvitegravir information and remove telaprevir information.

We have completed our review of this supplemental application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

## **CONTENT OF LABELING**

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at

Content of labeling must be identical to the enclosed labeling (text for the package insert and Medication Guide), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

You may request advisory comments on proposed introductory advertising and promotional labeling.
