Please refer to your Supplemental New Drug Application (sNDA) dated and received December 10, 2014, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Savella (milnacipran HCl) Tablets.

This Prior Approval supplemental application proposes revisions to the **HIGHLIGHTS**, **CONTRAINDICATIONS**, **WARNINGS AND PRECAUTIONS**, and **PATIENT COUNSELING INFORMATION** sections of the Package Insert and the **MEDICATION GUIDE**, regarding angle closure glaucoma.

APPROVAL & LABELING

Content of labeling must be identical to the enclosed labeling (text for the package insert and Medication Guide), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).
