Please refer to your New Drug Application (NDA) dated September 27, 2013, received September 27, 2013, submitted pursuant to section 505(b)(2) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Meropenem for Injection USP and Sodium Chloride Injection USP in the Duplex Container.

We acknowledge receipt of your amendments dated October 30, 2014 and April 10, 2015.

The October 30, 2014, submission constituted a complete response to our July 25, 2014, action letter.

This new drug application provides for the use of Meropenem for Injection, USP and Sodium Chloride Injection USP in the Duplex Container, 500 mg and 1 g, for the treatment of complicated Skin and Skin Structure Infections, complicated Intra-abdominal Infections, and Bacterial Meningitis.

We have completed our review of this application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed agreed-upon labeling text.
