Dear Ms. Kurtz-Colone:

Please refer to your Supplemental New Drug Application (sNDA) dated and received December 12, 2014, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for OLYSIO[®] (simeprevir) 150 mg capsules.

We acknowledge receipt of your amendments dated April 10, 2015, April 23, 2015, April 30, 2015, September 11, 2015, September 25, 2015, September 30, 2015 and October 1, 2015.

This “Prior Approval” supplemental new drug application was submitted to expand the Indications and Usage to include the treatment of chronic hepatitis C Genotype 4.

APPROVAL & LABELING

We have completed our review of this supplemental application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at <http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>. Content of labeling must be identical to the enclosed labeling (text for the package insert and text for the patient package insert), with the addition of any labeling changes in pending “Changes Being Effected” (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

REQUIRED PEDIATRIC ASSESSMENTS

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients, new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for the claimed indication(s) in pediatric patients unless this requirement is waived, deferred, or inapplicable.

We refer to the partial waiver, previously granted on November 22, 2013, waiving the pediatric study requirement for ages less than 3 years because necessary studies are impossible or highly impractical. Chronic hepatitis C infection is relatively benign in this age group, spontaneous clearance is possible and the risk-benefit balance would not favor treatment.

We also refer to the deferral, previously granted on November 22, 2013, deferring the pediatric study requirement for ages 3 through 17 years, because this product is approved for use in adults and the pediatric studies have not been completed.
