Dear Dr. Abeygunawardana:

Please refer to your Supplemental New Drug Applications (sNDA) dated August 18, 2014, received August 18, 2014 submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for ISENTRESS® (raltegravir) for oral suspension, ISENTRESS® (raltegravir) chewable tablets, for oral use, and ISENTRESS® (raltegravir) film-coated tablets, for oral use.

We acknowledge receipt of your amendments dated February 12, 2015 and February 16, 2015.

These “Changes Being Effected” supplemental new drug applications propose to update DRUG INTERACTIONS, Effect of Other Agents on the Pharmacokinetics of Raltegravir subsection, including Table 8, with updated information regarding the coadministration of raltegravir within 6 hours of taking: aluminum and/or magnesium containing antacid.

We have completed our review of these supplemental applications, as amended. They are approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

WAIVER OF HIGHLIGHTS SECTION

Please note that we have previously granted a waiver of the requirements of 21 CFR 201.57(d)(8) regarding the length of Highlights of prescribing information.

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at

<http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>. Content of labeling must be identical to the enclosed labeling (text for the package insert and text for the patient package insert), with the addition of any labeling changes in pending “Changes Being Effected” (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Information on submitting SPL files using eList may be found in the guidance for industry titled “SPL Standard for Content of Labeling Technical Qs and As at <http://www.fda.gov/downloads/DrugsGuidanceComplianceRegulatoryInformation/Guidances/UCM072392.pdf>

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for these NDAs, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in these supplemental applications, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

REPORTING REQUIREMENTS

We remind you that you must comply with reporting requirements for an approved NDA (21 CFR 314.80 and 314.81).
