Please refer to your Supplemental New Drug Applications (sNDAs) submitted December 22, 2015 under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for DIANEAL 1.5%, 2.5% and 4.25% Dextrose Peritoneal Dialysis Solution, DIANEAL ULTRABAG (Dianeal PD-2 Peritoneal Dialysis Solution with Dextrose), and, DIANEAL ULTRABAG (Dianeal Low Calcium Peritoneal Dialysis Solution with Dextrose).

These “Prior Approval” supplemental new drug applications provide for revisions to comply with the formatting requirements of 21 CFR 201.56 and 201.57. Numerous editorial and organizational changes were made throughout the label to improve clarity.

Content of labeling must be identical to the enclosed labeling (text for the package insert), with the addition of any labeling changes in pending “Changes Being Effectuated” (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Information on submitting SPL files using eList may be found in the guidance for industry titled “SPL Standard for Content of Labeling Technical Qs and As at

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that includes labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

REPORTING REQUIREMENTS

We remind you that you must comply with reporting requirements for an approved NDA (21 CFR 314.80 and 314.81).
