Please refer to your Supplemental New Drug Application (sNDA) dated February 13, 2015, received February 13, 2015, and your amendments, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Lamprene (clofazimine) Capsules, 50 mg.

This Prior Approval supplemental new drug application provides for labeling in the Physician's Labeling Rule (PLR) format.

### **APPROVAL & LABELING**

We have completed our review of this supplemental application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

# **CONTENT OF LABELING**

Content of labeling must be identical to the enclosed labeling (text for the package insert) with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.
