Please refer to your Supplemental New Drug Application (sNDA) dated January 28, 2016, received January 28, 2016, and your amendments, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Jadenu<sup>®</sup> (deferasirox) tablets, 90 mg, 180 mg, and 360 mg.

This Prior Approval supplemental new drug application provides for updates to the USPI Section 5.6 Hypersensitivity, Section 5.7 Severe Skin Reactions, Section 6.1 Clinical Trials Experiences and Section 6.2 Postmarketing Experience.

# **APPROVAL & LABELING**
