Please refer to your Supplemental New Drug Applications (sNDAs), Supplement 049 and Supplement 050 dated and received June 20, 2017, and your amendments submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for DROXIA® (hydroxyurea) capsules, 200 mg, 300 mg, and 400 mg, and HYDREA® (hydroxyurea) capsules, 500 mg, respectively.

Supplement 049

This Prior Approval supplemental new drug application provides for revisions to Droxia United States Prescribing Information (USPI) including the addition of nail hyperpigmentation and hypersensitivity, drug-induced fever to section 6 Adverse Reactions. In addition, the Patient Information has been converted to a Medication Guide.

Supplement 050

This Prior Approval supplemental new drug application provides for revisions to Hydrea USPI including the addition of nail hyperpigmentation and hypersensitivity, drug-induced fever to section 6 Adverse Reactions.

APPROVAL & LABELING

We have completed our review of these supplemental applications, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm. Content of labeling must be identical to the enclosed labeling (text for the package insert, text for the Medication Guide), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(1)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

REQUIRED PEDIATRIC ASSESSMENTS

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients, new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for the claimed indication(s) in pediatric patients unless this requirement is waived, deferred, or inapplicable.

Because none of these criteria apply to your application, you are exempt from this requirement.
