Dear Ms. Harrell:

Please refer to your Supplemental New Drug Application (sNDA) dated and received June 12, 2017, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Vaseretic (enalapril maleate/hydrochlorothiazide) 10/25 mg Tablets.

This Prior Approval supplemental new drug application provides for the following revisions to the approved labeling:

1. Under **CONTRAINDICATIONS**, the following text was added:

VASERETIC is contraindicated in combination with a neprilysin inhibitor (e.g., sacubitril). Do not administer VASERETIC within 36 hours of switching to or from sacubitril/valsartan, a neprilysin inhibitor (see **WARNINGS**)

2. Under **WARNINGS**, *Head And Neck Angioedema*, the following text was added to the second paragraph:

Patients receiving coadministration of ACE inhibitor and mTOR (mammalian target of rapamycin) inhibitor (e.g., temsirolimus, sirolimus, everolimus) therapy or a neprilysin inhibitor may be at increased risk for angioedema (see **PRECAUTIONS**).

3. Under **PRECAUTIONS**, **Drug Interactions**, the following section was added:

Neprilysin Inhibitors

Patients taking concomitant neprilysin inhibitors may be at increased risk for angioedema. (see **WARNINGS**).

mTOR (mammalian target of rapamycin) inhibitors:

Patients receiving coadministration of ACE inhibitor and mTOR inhibitor (e.g., temsirolimus, sirolimus, everolimus) therapy may be at increased risk for angioedema (see **WARNINGS**).

4. The manufacturing information was updated.
5. Multiple editorial revisions (mostly formatting changes) were noted throughout the label.
6. The revision date and version number were updated.

APPROVAL & LABELING

We have completed our review of this supplemental application and it is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.
