For administrative purposes, designate this submission "Final Printed Labeling for approved NDA 20516/S-035." Approval of this submission by FDA is not required before the labeling is used.

All drug establishment registration and drug listing information is to be submitted to FDA electronically, via the FDA automated system for processing structured product labeling (SPL) files (eLIST).
