Dear Ms. Burtness:

Please refer to your Supplemental New Drug Application (sNDA) dated February 24, 2017, received February 24, 2017, and your amendment, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Cefobid (cefoperazone sodium) Injection, 1g, 2g and 10g.

This “Changes Being Effected” supplemental new drug application provides for revisions to the **WARNINGS, Hypersensitivity Reactions** subsection, **PRECAUTIONS, General** subsection and **ADVERSE REACTIONS, Post-Marketing Experience** subsection, of the prescribing information, along with minor editorial revisions.

APPROVAL & LABELING

CONTENT OF LABELING

Content of labeling must be identical to the enclosed labeling, with the addition of any labeling changes in pending “Changes Being Effected” (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

REPORTING REQUIREMENTS

We remind you that you must comply with reporting requirements for an approved NDA (21 CFR 314.80 and 314.81).
