Dear Dr. Lad:

Please refer to your Supplemental Biologics License Application (sBLA), dated and received June 13, 2017, and your amendments, submitted under section 351(a) of the Public Health Service Act for Lemtrada (alemtuzumab).

This Prior Approval supplemental biologics application provides for revisions to the USPI related to the risk for *Listeria monocytogenes* infections. These comprise revisions to the following portions of labeling:

- Section 5.9 (Warning and Precautions; Infections), including information pertaining to the occurrence of fatal cases of *Listeria meningoenzephalitis* and other changes
- Section 2.2 (Dosage and Administration; Testing and Procedures Prior to Treatment), including a revision from the prior title of "Vaccinations," a recommendation to instruct patients to avoid potential sources of *Listeria monocytogenes* prior to treatment, a cross-reference to subsection 2.6, which includes other recommendations pertaining to laboratory tests, and a recommendation for tuberculosis screening to correspond to the existing recommendation under section 5.9
- Section 17 (Patient Counseling Information)
- The Medication Guide

**APPROVAL & LABELING**

We have completed our review of this supplemental application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

## **CONTENT OF LABELING**

As soon as possible, but no later than 14 days from the date of this letter, submit, via the FDA automated drug registration and listing system (eLIST), the content of labeling [21 CFR 601.14(b)] in structured product labeling (SPL) format, as described at <http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>, that is identical to the enclosed labeling (text for the prescribing information and Medication Guide) and include the labeling changes proposed in any pending “Changes Being Effectuated” (CBE) supplements. Information on submitting SPL files using eLIST may be found in the guidance for industry titled “SPL Standard for Content of Labeling Technical Qs and As” at <http://www.fda.gov/downloads/Drugs/GuidanceComplianceRegulatoryInformation/Guidances/UCM072392.pdf>.

The SPL will be accessible via publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this BLA, including pending “Changes Being Effectuated” (CBE) supplements, for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 601.12(f)] in MS Word format that includes the changes approved in this supplemental application.

You may request advisory comments on proposed introductory advertising and promotional labeling. To do so, submit, in triplicate, a cover letter requesting advisory comments, the proposed materials in draft or mock-up form with annotated references, and the prescribing information to:

Within 7 days of receipt of this letter, submit your statement of intent to comply with 21 CFR 601.12(a)(4) to the address above, by fax to 301-847-8444, or electronically in eCTD format.
