Please refer to your Supplemental New Drug Application (sNDA) dated and received December 18, 2015, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Kenalog-10 Injection (triamcinolone acetonide injectable suspension, USP), 10 mg/mL.

This "Changes Being Effected" supplemental new drug application provides for revisions to the Description section of the prescribing information to reflect the changes approved on October 23, 2015, for Kenalog-10 NDA 12041/S-043.

# APPROVAL & LABELING

Content of labeling must be identical to the enclosed labeling (text for the package insert), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

## **CARTON AND IMMEDIATE CONTAINER LABELS**

We acknowledge your December 18, 2015, submission containing final printed carton and container labels.

#### **REQUIRED PEDIATRIC ASSESSMENTS**

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients, new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for the claimed indication(s) in pediatric patients unless this requirement is waived, deferred, or inapplicable.
