Dear Dr. Kozlowski:

Please refer to your Supplemental Biologics License Application (sBLA), dated December 21, 2017, received December 21, 2017, and your amendments, submitted under section 351(a) of the Public Health Service Act for Neulasta[®] (pegfilgrastim), 6 mg per 0.6 mL.

This Prior Approval supplemental biologics application provides for the following updates:

- A new warning for aortitis in Section 5.11 of the United States Prescribing Information (USPI). The patient package inserts for both the on-body injector (OBI) and the prefilled syringes have been updated to reflect the addition of the new warning.
- Revisions to the USPI to comply with the Pregnancy and Lactation Labeling Rule.
- Additional revisions to the USPI in Section 6.3 Post-Marketing Experience, Section 17 Patient Counseling Information, and minor editorial changes in multiple sections.
- Minor revisions to the OBI healthcare provider instructions for use, OBI patient instructions for use, and OBI reference guide.

APPROVAL & LABELING

We have completed our review of this supplemental application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

WAIVER OF HIGHLIGHTS SECTION

Please note that we have previously granted a waiver of the requirements of 21 CFR 201.57(d)(8) regarding the length of Highlights of prescribing information.

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit, via the FDA automated drug registration and listing system (eLIST), the content of labeling [21 CFR 601.14(b)] in structured product labeling (SPL) format, as described at <http://www.fda.gov/ForIndustry/DataStandards/StructuredProductLabeling/default.htm>, that is identical to the enclosed labeling (text for the prescribing information, patient package inserts, instructions for use, and reference guide) and include the labeling changes proposed in any pending “Changes Being Effected” (CBE) supplements. Information on submitting SPL files using eLIST may be found in the guidance for industry titled “*SPL Standard for Content of Labeling Technical Qs and As*” at <http://www.fda.gov/downloads/Drugs/GuidanceComplianceRegulatoryInformation/Guidances/UCM072392.pdf>.

The SPL will be accessible via publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this BLA, including pending “Changes Being Effected” (CBE) supplements, for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 601.12(f)] in MS Word format that includes the changes approved in this supplemental application.

REQUIRED PEDIATRIC ASSESSMENTS

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients (which includes new salts and new fixed combinations), new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for the claimed indication(s) in pediatric patients unless this requirement is waived, deferred, or inapplicable.

Because none of these criteria apply to your application, you are exempt from this requirement.

PROMOTIONAL MATERIALS

You may request advisory comments on proposed introductory advertising and promotional labeling. To do so, submit, in triplicate, a cover letter requesting advisory comments, the proposed materials in draft or mock-up form with annotated references, and the prescribing information to:
