Please refer to your Supplemental New Drug Application (sNDA) dated May 7, 2018, received May 7, 2018, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Xofigo[®] (radium Ra 223 dichloride).

This Prior Approval supplemental new drug application proposes to revise the WARNINGS AND PRECAUTIONS section of the Full Prescribing Information (FPI) to be updated with detailed information on the clinical findings on the potential risk of Xofigo[®], abiraterone acetate plus prednisone/prednisolone combination from ERA-223.

APPROVAL & LABELING

We have completed our review of this supplemental application. It is approved, effective on the date of this letter, for use as recommended in the enclosed, agreed-upon labeling text.

CONTENT OF LABELING

Content of labeling must be identical to the enclosed labeling (text for the prescribing information), with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).
