Dear Dr. Jarmarwala :

Please refer to your supplemental new drug application (sNDA) dated and received on March 29, 2019, and your amendments, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for MAVYRET™ (glecaprevir and pibrentasvir) tablets, 100 mg/40 mg.

This Prior Approval supplemental new drug application provides for the following changes to the MAVYRET™ US Prescribing Information (USPI):

- Addition of safety and efficacy data for subjects with genotype (GT) 5 and 6 Hepatitis C Virus (HCV) infection from the ENDURANCE-5,6 study
- Contraindicate the use of MAVYRET™ in patients with moderate hepatic impairment (Child-Pugh B) or those with any history of prior hepatic decompensation
- Update WARNINGS AND PRECAUTIONS with new subsection 5.2, Risk of Hepatic Decompensation/Failure in Patients with Evidence of Advanced Liver Disease
- Update ADVERSE REACTIONS with subsection, 6.2, Post Marketing Experience
- Update DRUG INTERACTIONS, Established and Other Potential Drug Interactions subsection, with information regarding INR fluctuations and dysglycemia
- Update DRUG INTERACTIONS with subsection 7.4, Medication-Assisted Treatment (MAT) for Opioid Use Disorder, to highlight drug interaction information
- To make corresponding changes to the Patient Information

APPROVAL & LABELING

We have completed our review of this application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed agreed-upon labeling.

WAIVER OF ½ PAGE LENGTH REQUIREMENT FOR HIGHLIGHTS

Please note that we have previously granted a waiver of the requirements of 21 CFR 201.57(d)(8) regarding the length of Highlights of Prescribing Information.

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at FDA.gov.¹ Content of labeling must be identical to the enclosed labeling (text for the Prescribing Information, Patient Package Insert), with the addition of any labeling changes in pending “Changes Being Effected” (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Information on submitting SPL files using eList may be found in the guidance for industry *SPL Standard for Content of Labeling Technical Qs and As*.²

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in Microsoft Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes. To facilitate review of your submission(s), provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

REQUIRED PEDIATRIC ASSESSMENTS

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients (which includes new salts and new fixed combinations), new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for

the claimed indication in pediatric patients unless this requirement is waived, deferred, or inapplicable.

Because none of these criteria apply to your application, you are exempt from this requirement.

FULFILLMENT OF POSTMARKETING REQUIREMENT(S)/COMMITMENT(S)

We have received your submission dated March 29, 2019, containing the final report for the following postmarketing commitment listed in the August 3, 2017, approval letter.

3246-2 Submit the final SVR12 report and datasets, including drug resistance datasets, for the ongoing clinical trial M16-126, evaluating glecaprevir and pibrentasvir in patients with HCV genotype 5 or 6 infection.

We have reviewed your submission and conclude that the above commitment was fulfilled.

All promotional materials that include representations about your drug product must be promptly revised to be consistent with the labeling changes approved in this supplement, including any new safety information [21 CFR 314.70(a)(4)]. The revisions in your promotional materials should include prominent disclosure of the important new safety information that appears in the revised labeling. Within 7 days of receipt of this letter, submit your statement of intent to comply with 21 CFR 314.70(a)(4) to the address above, by fax to 301-847-8444, or electronically in eCTD format.
