Please refer to your Supplemental New Drug Application (sNDA) dated and received May 26, 2022, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Fludeoxyglucose F18 Injection.

This “Changes Being Effected” supplemental new drug application provides for labeling changes as specified in the agency’s supplement request letter dated 05/05/2022.

Content of labeling must be identical to the enclosed labeling (text for the prescribing information) with the addition of any labeling changes in pending “Changes Being Effected” (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Information on submitting SPL files using eLIST may be found in the guidance for industry titled *SPL Standard for Content of Labeling Technical Qs and As* at <http://www.fda.gov/downloads/Drugs/GuidanceComplianceRegulatoryInformation/Guidances/UCM072392.pdf>.

The SPL will be accessible via publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an

action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in MS Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes, and annotate each change. To facilitate review of your submission, provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

CARTON AND CONTAINER LABELS

We acknowledge your December 8, 2022, submission containing carton and container labeling.

We remind you that you must comply with reporting requirements for an approved NDA (21 CFR 314.80 and 314.81).
