Dear Mr. Reightler:¹

Please refer to your supplemental new drug application (sNDA) dated and received, May 5, 2023, submitted pursuant to section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Yosprala (aspirin and omeprazole) delayed-release tablets.

We also refer to our letter dated April 14, 2023, notifying you, under Section 505(o)(4) of the FDCA, of new safety information that we have determined should be included in the labeling for proton pump inhibitor (PPI) products. This information pertains to the risk of erectile dysfunction.

This supplemental new drug application provides for revisions to the labeling for Yospralara, consistent with our April 14, 2023, letter adding erectile dysfunction in section 6.2 Postmarketing Experience.

APPROVAL & LABELING

We have completed our review of this application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed agreed-upon labeling with minor editorial revisions listed below and reflected in the enclosed labeling.

- Horizontal lines added between Highlights and the Table of Contents and between the Table of Contents and the Full Prescribing Information.
- Revision date for the Medication Guide revised to the last approved change (03/2022).

CONTENT OF LABELING

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(l)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at FDA.gov.² Content of labeling must be identical to the enclosed labeling (Prescribing Information), with the addition of any labeling changes in pending “Changes Being Effected” (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Information on submitting SPL files using eList may be found in the guidance for industry *SPL Standard for Content of Labeling Technical Qs and As*.³

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this NDA, including CBE supplements for which FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(l)(1)(i)] in Microsoft Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes. To facilitate review of your submission(s), provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

REPORTING REQUIREMENTS

We remind you that you must comply with reporting requirements for an approved NDA (21 CFR 314.80 and 314.81).
