# CORRECTED SUPPLEMENT APPROVAL/ FULFILLMENT OF POSTMARKETING COMMITMENT

#### Dear Angela Wolford:

Please refer to your supplemental New Drug Applications (sNDAs) dated November 11, 2022, received November 14, 2022 (S-017), and March 17, 2023, received March 17, 2023 (S-018), and their amendments, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for IBRANCE (palbociclib) capsule.

We also refer to our approval letter dated September 6, 2023, which contained the following errors: Dated submission and receipt date for supplement 17 updated to November 11, 2022 and November 14, 2022, respectively.

Supplement 017 provides for supplemental clinical study reports (sCSR) and datasets from the final OS analysis from Study A5481008 (PALOMA-2) to fulfill postmarketing commitment 3192-1:

Submit the overall survival (OS) data and results from Trial A5481008, PALOMA-2, "A Randomized, Multicenter, Double-blind Phase 3 Study of PD-0332991 (Oral CDK 4/6 Inhibitor) Plus Letrozole Versus Placebo Plus Letrozole for the Treatment of Postmenopausal Women with ER(+), HER2(-) Breast Cancer Who Have Not Received Any Prior Systemic Anti-Cancer Treatment For Advanced Disease", and to update Section 14 of the USPI for Ibrance capsules to include the final OS data.

The purpose of this supplement is to fulfill the PMC and add the OS data from Study A5481008 (PALOMA-2) to Section 14 of the USPI.

Supplement 018, per the recommendation by the Pharmacovigilance Risk Assessment Committee (PRAC) provides for the inclusion of Palmar-Plantar Errythrodysesthesia Syndrome (PPES) in the adverse drug reaction (ADR) section of Section 6.2 Postmarking Experience.

#### **APPROVAL & LABELING**

We have completed our review of these applications, as amended. They are approved, effective on the date of this letter, for use as recommended in the enclosed agreed-upon labeling.

## **CONTENT OF LABELING**

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(I)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at FDA.gov.<sup>1</sup> Content of labeling must be identical to the enclosed labeling text for the Prescribing Information and Patient Package Insert, with the addition of any labeling changes in pending "Changes Being Effected" (CBE) supplements, as well as annual reportable changes not included in the enclosed labeling.

Information on submitting SPL files using eList may be found in the guidance for industry SPL Standard for Content of Labeling Technical Qs and As.<sup>2</sup>

The SPL will be accessible from publicly available labeling repositories.

Also within 14 days, amend all pending supplemental applications that include labeling changes for this NDA, including CBE supplements for which the FDA has not yet issued an action letter, with the content of labeling [21 CFR 314.50(I)(1)(i)] in Microsoft Word format, that includes the changes approved in this supplemental application, as well as annual reportable changes. To facilitate review of your submission(s), provide a highlighted or marked-up copy that shows all changes, as well as a clean Microsoft Word version. The marked-up copy should provide appropriate annotations, including supplement number(s) and annual report date(s).

## REQUIRED PEDIATRIC ASSESSMENTS

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients (which includes new salts and new fixed combinations), new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for the claimed indication in pediatric patients unless this requirement is waived, deferred, or inapplicable.

Because none of these criteria apply to your application, you are exempt from this requirement.

### FULFILLMENT OF POSTMARKETING COMMITMENT

We have received your submission dated November 11, 2022, containing the final report for the following postmarketing commitment listed in the March 31, 2017, approval letter.

3192-1 Submit the overall survival (OS) data and results from Trial A5481008, PALOMA-2, "A Randomized, Multicenter, Double-blind Phase 3 Study of PD-0332991 (Oral CDK 4/6 Inhibitor) Plus Letrozole Versus Placebo Plus Letrozole for the Treatment of Postmenopausal Women with ER (+), HER2 (-) Breast Cancer Who Have Not Received Any Prior Systemic AntiCancer Treatment For Advanced Disease".

We have reviewed your submission and conclude that the above commitment was fulfilled.

This completes all of your postmarketing requirements acknowledged in our March 31, 2017, letter. You are not required to report on the status of closed (released or fulfilled) PMRs/PMC in your annual report required under 21 CFR 314.81(b)(2)(vii) of the FD&CA.

You must submit final promotional materials and Prescribing Information, accompanied by a Form FDA 2253, at the time of initial dissemination or publication [21 CFR 314.81(b)(3)(i)]. Form FDA 2253 is available at FDA.gov.<sup>4</sup> Information and Instructions for completing the form can be found at FDA.gov.<sup>5</sup> All promotional materials that include representations about your drug product must be promptly revised to be consistent with the labeling changes approved in this supplement, including any new safety- related information [21 CFR 314.70(a)(4)]. The revisions in your promotional materials should include prominent disclosure of the important new safety-related information that appears in the revised labeling. Within 7 days of receipt of this letter, submit your statement of intent to comply with 21 CFR 314.70(a)(4).
