Dear Chinna Chinnakaruppan:

Please refer to your supplemental new drug application (sNDA) dated and received November 14, 2023, and your amendments, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FD&C Act) for Nizoral A-D (ketoconazole) shampoo, 1%.

This “Prior Approval” supplemental new drug application provides for a modified Nizoral anti-dandruff shampoo + conditioner product. We specifically note the addition of the “conditioner” claim on the labeling, which is not a drug claim. Therefore, this approval does not encompass the “conditioner” claim. Because this product is also intended for use as a cosmetic under section 201(i) of the FD&C Act, you must also meet any relevant cosmetic requirements.

APPROVAL & LABELING

We have completed our review of this application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed agreed-upon labeling.

LABELING

Submit final printed labeling (FPL) as soon as they are available, but no more than 30 days after they are printed. The FPL must be identical to the 11 oz outer carton and immediate container labels submitted on January 12, 2024, and must be in the “Drug Facts” format (21 CFR 201.66), where applicable.

We remind you to remove the “New!” flag on your product labels six months after the product has been introduced to the marketplace. The FPL should be submitted electronically according to the guidance for industry *Providing Regulatory Submissions in Electronic Format — Certain Human Pharmaceutical Product Applications and Related Submissions Using the eCTD Specifications*.¹ For administrative purposes, designate this submission “**Final Printed Labeling for approved NDA 020310/S-032.**” Approval of this submission by FDA is not required before the labeling is used.

DRUG REGISTRATION AND LISTING

All drug establishment registration and drug listing information is to be submitted to FDA electronically, via the FDA automated system for processing structured product labeling (SPL) files (eLIST). At the time that you submit your final printed labeling (FPL), the content of labeling (Drug Facts) should be submitted in SPL format as described at FDA.gov.² Information on submitting SPL files using eLIST may be found in the guidance for industry *SPL Standard for Content of Labeling Technical Qs and As*. In addition, representative container or carton labeling, whichever includes Drug Facts, (where differences exist only in the quantity of contents statement) should be submitted as a JPG file.

REPORTING REQUIREMENTS

We remind you that you must comply with reporting requirements for an approved NDA (21 CFR 314.80 and 314.81).
