Please refer to your New Drug Application (NDA) dated December 27, 2013, received December 27, 2013, and your amendments, submitted pursuant to section 505(b)(2) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Caspofungin Acetate for Injection.

We acknowledge receipt of your amendment dated October 31, 2016, which constituted a complete response to our November 20, 2015, action letter.

This new drug application provides for the use of Caspofungin Acetate for Injection in adults and pediatric patients (3 months and older) for:

Content of labeling must be identical to the enclosed labeling (text for the package insert). The SPL will be accessible via publicly available labeling repositories.

CARTON AND IMMEDIATE CONTAINER LABELS

Submit final printed carton and immediate container labels that are identical to the enclosed carton and immediate container labels as soon as they are available, but no more than 30 days after they are printed. Please submit these labels electronically according to the guidance for industry *Providing Regulatory Submissions in Electronic Format – Human Pharmaceutical Product Applications and Related Submissions Using the eCTD Specifications (June 2008)*. Alternatively, you may submit 12 paper copies, with 6 of the copies individually mounted on heavy-weight paper or similar material. For administrative purposes, designate this submission **“Final Printed Carton and Container Labels for approved NDA 206110.”** Approval of this submission by FDA is not required before the labeling is used.
