Please refer to your new drug application (NDA) dated and received October 22, 2021, and your amendments, submitted under section 505(b) of the Federal Food, Drug, and Cosmetic Act (FDCA) for Brenzavvy (bexagliflozin) tablets.

We acknowledge receipt of your major amendment dated June 6, 2022, which extended the goal date by three months.

This NDA provides for the use of Brenzavvy (bexagliflozin) tablets as an adjunct to diet and exercise to improve glycemic control in adults with type 2 diabetes mellitus.

#### **APPROVAL & LABELING**

We have completed our review of this application, as amended. It is approved, effective on the date of this letter, for use as recommended in the enclosed agreed-upon labeling.

#### WAIVER OF 1/2 PAGE LENGTH REQUIREMENT FOR HIGHLIGHTS

We are waiving the requirements of 21 CFR 201.57(d)(8) regarding the length of Highlights of Prescribing Information. This waiver applies to all future supplements containing revised labeling unless we notify you otherwise.

#### **CONTENT OF LABELING**

As soon as possible, but no later than 14 days from the date of this letter, submit the content of labeling [21 CFR 314.50(I)] in structured product labeling (SPL) format using the FDA automated drug registration and listing system (eLIST), as described at FDA.gov.<sup>1</sup> Content of labeling must be identical to the enclosed labeling (text for the Prescribing Information and Medication Guide) as well as annual reportable changes not included in the enclosed labeling. Information on submitting SPL files using eLIST

may be found in the guidance for industry *SPL Standard for Content of Labeling Technical Qs and As.*<sup>2</sup>

The SPL will be accessible via publicly available labeling repositories.

#### **CARTON AND CONTAINER LABELING**

Submit final printed carton and container labeling that are identical to the enclosed carton and container labeling, as soon as they are available, but no more than 30 days after they are printed. Please submit these labeling electronically according to the guidance for industry *SPL Standard for Content of Labeling Technical Qs & As.* For administrative purposes, designate this submission "Final Printed Carton and Container Labeling for approved NDA 214373." Approval of this submission by FDA is not required before the labeling is used.

#### **DATING PERIOD**

Based on the stability data submitted to date, the expiry dating period for Brenzavvy (bexagliflozin) tablets shall be 60 months from the date of manufacture when stored at 20°C to 25°C.

#### **ADVISORY COMMITTEE**

Your application for Brenzavvy was not referred to an FDA advisory committee because this drug is not the first in its class and it did not raise efficacy or safety issues requiring external input.

#### REQUIRED PEDIATRIC ASSESSMENTS

Under the Pediatric Research Equity Act (PREA) (21 U.S.C. 355c), all applications for new active ingredients (which includes new salts and new fixed combinations), new indications, new dosage forms, new dosing regimens, or new routes of administration are required to contain an assessment of the safety and effectiveness of the product for the claimed indication in pediatric patients unless this requirement is waived, deferred, or inapplicable.

We are waiving the pediatric study requirement for ages 0 to 9 years because necessary studies are impossible or highly impracticable. This is because there are too few children in this age range with type 2 diabetes mellitus to study.

We are deferring submission of your pediatric study for ages 10 to 17 years (inclusive) for this application because this product is ready for approval for use in adults and the pediatric study has not been completed.

Your deferred pediatric study required by section 505B(a) of the FDCA is a required postmarketing study. The status of this postmarketing study must be reported annually according to 21 CFR 314.81 and section 505B(a)(4)(C) of the FDCA. This required study is listed below.

Conduct a 24-week, randomized, double-blind, placebo-controlled, parallel group study of the safety, efficacy, pharmacokinetics (PK), and pharmacodynamics (PD) of bexagliflozin for the treatment of type 2 diabetes mellitus in pediatric patients ages 10 to 17 years (inclusive), followed by a 28-week double-blind, controlled extension. The bexagliflozin dose will be determined based on the initial PK/PD lead-in portion of the study.


