## Draft Guidance on Nystatin; Triamcinolone Acetonide October 2022

This draft guidance, when finalized, will represent the current thinking of the Food and Drug Administration (FDA, or the Agency) on this topic. Dosage Form; Route: Ointment; topical

**Recommended Studies:** Characterization test

Acceptable comparative physicochemical and structural (Q3) characterization of the test product and reference standard should establish that they are the same dosage form, with identical strength. Refer to the most recent version of the FDA guidance for industry on *Physicochemical and Structural (Q3) Characterization of Topical Drug Products Submitted in ANDAs*<sup>a</sup> for additional information regarding appropriate comparative Q3 characterization tests.
