Draft Guidance on Drospirenone; Estetrol
October 2024

Analytes to measure:	Drospirenone and estetrol in plasma

Conduct comparative dissolution testing on 12 dosage units for each of the test product and reference listed drug (RLD).¹ Specifications will be determined upon review of the abbreviated new drug application.
